TALBOT COUNTY BUSINESS CENTER

Site will transition to a construction zone in January 2024; Letters sent to tenants in December 2022. Leases will end June 2023. Working with Talbot County government tenants on individual relocation plans.

JOINT PERMIT APPLICATION (JPA) (NON-TIDAL WETLAND IMPACTS)

Coordination continues Maryland Department of the Environment (MDE) and US Army Corps of Engineers (USACE) on permitting and associated mitigation for the RW 4-22 project.

FOREST CONSERVATION ACT

Coordination ongoing with the Town of Easton (TOE) regarding mitigation requirements for the RW 4-22 project; County has requested a variance to the Town's Forest Conservation Ordinance and Natural Resources (MDNR) has allowed the variance.

3. AUTOMATED WEATHER OBSERVING SYSTEM (AWOS) REPLACEMENT

Bid No. 22-13 was awarded to Glenelg Construction Inc for \$428,700. MAA grant fully executed for \$321,525. Including AECOM's price proposal for \$36,744, the actual cost to the Airport will not exceed \$143,919 and is included in the FY2023 budget.

4. T-HANGAR COMPLIANCE

Insurance requirements increasing to \$1 Million Liability as recommended by Insurance Company; New Leases will be sent out with expectation to have all T Hangar tenants on new leases by June 30, 2023. Airport working with tenants to resolve "unairworthy, in-active" aircraft storage issues.
